- Ian Dye, Assistant Director of Athletics, Aquatics & Auxiliary Services at Bucknell University, has agreed to consult on swimming pool operations.
- The swimming pool is losing water for an unknown reason. Ian Dye has made some suggestions concerning the problem. The problem will be investigated during the off season.
- PA Dept. of Health visited the pool and gave suggestions on lifeguard placement.
- Lifeguard attendance, staffing, and job performance remained a problem in 2025.
- Swim lessons were a success this year.
- The Energy Gymnastics team has gained members.

 Gators Swim Team was happy with using the community pool this season. There will be discussions about next year's usage.
